

Game 1495 NASCAR® Top Prize Details

Winners of the 1495 NASCAR top prize will win a Daytona VIP trip package in addition to the standard \$100,000 top prize

The VIP trip package includes the following:

- A five-night / six-day trip for two (2) to the 2026 NASCAR Daytona 500® race weekend in Daytona Beach, Florida.
- **Airfare:** Round-trip coach class air transportation for two (2) from a major airport near the winner's home (as determined by the Arizona Lottery) to Orlando, Florida (MCO).
- **Accommodations:** Five (5) nights' standard hotel accommodation (one room, double occupancy) at a hotel in the Orlando/Lake Mary area, selected by the Arizona Lottery.
- **Ground Transportation:** Round-trip transportation between the Orlando airport and the hotel, as well as daily scheduled group transportation between the hotel and the Daytona International Speedway®.
- **Race Experience & Hospitality:**
 - Two (2) Hospitality Tickets to the all-inclusive Daytona 500 Club® Hospitality Lounge and the Hardrock Fan Zone Experience from Thursday through Sunday of the race weekend.
 - Exclusive access for two (2) to the Daytona 500® Post-Race Victory Lane Celebration on Sunday.
 - Admission for two (2) to a Champions Luncheon Experience with a past Daytona 500® or NASCAR® Champion (champion's availability and identity subject to change).
- **Prize Pack:** One (1) premium Daytona 500® prize pack.

Trip Prize Conditions & Restrictions:

- **Travel Dates:** Travel is for the official 2026 NASCAR Daytona 500® weekend only (estimated to be mid-February 2026). Dates are fixed and cannot be changed. If the winner is unable to travel on the specified dates, the entire VIP Trip Package portion of the prize will be forfeited. No cash substitution for the trip portion of the prize will be awarded.
- **Debt Setoff:** In the event that Winner has a debt with the State of Arizona, Lottery will provide Winner a reasonable time frame to settle any debts to Arizona, otherwise, the Winner will be disqualified from receiving the trip portion of the prize.
- **Booking:** All travel arrangements, including airfare and hotel, will be booked by the Arizona Lottery's designated fulfillment partner. The winner must travel on the itinerary specified.
- **Incidentals:** The winner is responsible for all expenses not expressly included in the prize description, including but not limited to, meals, gratuities, personal incidentals, and

any transportation outside of the scheduled event transportation. A credit card will be required at hotel check-in for incidentals.

- **Contingency:** In the event the 2026 NASCAR Daytona 500® is canceled, rescheduled, or postponed for any reason, the Arizona Lottery reserves the right to substitute the trip portion of the prize with a prize of equal or greater value, or a cash equivalent, at its sole discretion. No other compensation will be provided.
- **Non-Transferability:** The VIP Trip Prize is non-transferable and may not be sold or assigned.
- **General Conditions:** By entering, participants agree to be bound by these Official Rules and the decisions of the Arizona Lottery, which are final. By accepting the prize, the winner agrees to release and hold harmless the Arizona Lottery, NASCAR, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees, and agents from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the promotion or receipt or use/misuse of any prize.
